ELIGIBILITY: The contest winner of the prize package at the Maui Sunday Market Drawing (“Drawing”) must be an individual 18 years or older at time of drawing. DRAWINGS: Entry forms will be provided at the Maui Sunday Market. The draw date is December 15, 2019 (the “Draw”). Entry forms will be available between 4:00pm-6:00pm.
